

## Licensing Requirements for Advisors in Canada

**Note: Advisors selling CM Products must comply with any Direct Seller Licensing requirements in their Province. In the Provinces listed below those requirements involve either applying for a permit or obtaining an Advisor ID Card from CM. CM will provide the Advisor ID Card upon request. For the provinces requiring permits, the links in the table below will take you to the form needed to make the permit application.**
